


# Background

#### **Laser Clearinghouse Mission:**


Ensure that DoD laser activities are conducted in a safe and responsible manner that protects space systems, their mission effectiveness, and humans in space, consistent with national security requirements



## Laser Clearinghouse



Organization






### **DoDI 3100.11 Current Process**

#### **Other USSTRATCOM responsibilities:**

- (1) Lasing Approval List
- (2) Deliberate illumination test schedule
- (3) Lasing Outside Auth. Parameters
- (4) Arms Control Treaty non-compliance
- (5) Database of lasers, satellite susceptibility & known incidents

Key: Comparable to old processes

New in Revised DoDI



# **Deconfliction Planning**

(6) RECEIVE AUTHORIZATION LETTER (5) PERFORM CAPABILITY VALIDATION (4) DEVELOP DECONFLICTION PLAN (3) SELECT DECONFLICTION APPROACH (2) RECEIVE RISK DETERMINATION (1) SUBMIT LASER REGISTRATION FORM

The entire process can take 4+ months depending on laser and scenario complexity



## Plan Development

- Process, templates and instructions available
  - Need to be registered with Space-Track.org
- Standard Centralized Deconfliction and Capability Validation Plan
  - Generic plan
- Tailored Appendix for laser program
  - Template to be provided by LCH.
  - Describes program specific deconfliction approach
  - Signed by program manager and LCH Branch Chief



### **Deconfliction Analysis**

- Keep-Out Cone analysis
  - Analysis of factors affecting uncertainties in laser pointing (includes failure modes)
  - Used as "buffer" in computing open firing windows
  - Template to be provided by LCH.
- Deconfliction System/Software Test Report
  - If automated approach, validation of capabilities
  - Template to be provided



### **Deconfliction Procedures**

- Certification memo procedures & training
- Certification memo DoDI 3100.11 compliance
  - Templates of each to be provided
- Site visit by LCH for end-to-end demonstration
  - Last step in the process ("graduation exercise")
- LCH Reports Handbook
  - To be provided
  - Defines various related phone calls and reports
- Space Deconfliction System (LCH software)
   Interface Control Document
  - Defines PRM and PAM formats (Deconfliction request and approval messages)



# Way Ahead

- Next steps:
  - Submit laser parameters in Laser Registration form
  - Draft Program-Specific Appendix to Standard Deconfliction Plan
